## THE CONSTITUTION

All resolutions submitted for members consideration last month were carried. 91 votes were received from 126 members. Statistics are as follow:

Resolution 1 To add "Society" to our name.

YES 81 NO 9 ABSTAIN

Resolution 2 To alter the name spelling to "Macfie".

YES 53 NO ABSTAIN

To add a new Aim.

YES 90 NO ABSTAIN

To remove the membership restriction on those under 18.

YES 50 NO 39 ABSTAIN 2

Resolution 5 To adopt the constitution.

YES 89 NO 2 ABSTAIN

Scru tineers were members C.R. (Charles) Macphee and Miss A.K. (Kaye) Macphee, both of Fern Tree Gully.

Several votes arrived after the deadline and were not included above. They supported the above vote.

There were some most interesting comments on some of the voting papers, and I am certainly far happier with the idea of having under 18 year old members than I was for some of the comments gave me a totally different view of the whole concept. With regard to the name change I like the look of the new name but there is certainly some sorrow in seeing the 'McPhee' spelling go - almost like losing an old friend. Incidentally, some McPhees voted for the new spelling, and some non-Mcphees voted for the retention of McPhee.

When we formed our Society on 3rd May 1974 the name was chosen by only 24 members and it was suggested to me that it was an opportune time to reconsider the name when we voted on the constitution as our membership had increased by over a hundred members. This was a reasonable suggestion and so it was done and a definite majority of members voting have decided on the change. Re-reading my comments relating to Resolution 2 and dealing with the name change, I'm afraid I may have given an incorrect impression by stating that 'Macfie' had historical and traditional support. I did not intend this to mean that I thought 'Macfie' to be the original spelling on the Clan name - I dont, and it isn't. But this spelling of the Clan name can be traced back into the 17th century at least and is the spelling generally used by Scottish historians since that era, and more significantly, it is the spelling used in Frank Adam's book The Clans, Septs and Regiments of the Scottish Highlands as revised by Sir Thomas Innes of Learney, Emeritus Lord Lyon, King of Arms.

# ELECTION OF OFFICE BEARERS

Under paragraph 7 of our constitution nominations are now called for for the election of the following Society Office Bearers for the 1976-1977 term of office:

President

Vice-President

State Vice-Presidents for New South Wales, Victoria and Queensland Treasurer

Nominations close with the Secretary on 20th November 1975 and are to be in writing specifying the nominee's name and nominated office. They must be signed by the proposed, seconder and by the nominee.

Only financial members are eligible to accept nomination for office, or to propose, second, or vote for nominees for office. Additionally, in the case of State Vice-Presidents, only financial members in the State concerned are eligible to accept nomination for such office, or to propose, second, or vote for nominees for such office.

### A SIGNAL HONOUR

I have recently been notified that the Lord Lyon, King of Arms, has made a Grant of Arms to Dr Earle Douglas MacPhee of Vancouver, Canada. I feel that this is an honour justly deserved by Dr MacPhee - Earle - in recognition of his untiring and selfless work over a number of years in writing the history of our Clan and in initiating action to reactivate the Clan. It is fitting that the Grant of Arms be made to Earle as the first of, we hope, a number of our Clan members to matriculate over the next few years.

The actual design of Farle's Arms is very similar to that of Macfie of Dreghorn which is the commonly published Coat of Arms for the Clan but which really only belongs to the Dreghorn family. Farle's motto is 'PRO HONORE'.

Membership Numbers. Our two Historians, our Treasurer and Secretary, and myself have all struck problems with the many similar names amongst our members - some are even identical - this is especially so when delving back into old family records. We have thus decided to give all members a number and as I work for an organisation that delights in having everybody and everything identified numerically I have evolved (in consultation) a suitably confusing system whereby each membership number will contain a letter to indicate the State a member resides in, two numbers to indicate the year of joining the Society, and a second series of numbers to indicate the order in which members joined. As an example N74-079 is the membership number of Miss Barbara McPhee of Pennant Hills - Barbara lives in New South Wales, joined the Society in 1974, and was the seventy ninth member to join. Foundation nembership was extended to those members who joined during the first year - ie 3rd May 1974 to 3rd May 1975. To indicate the Foundation members in the numbers game they have all been given 74 as the year of joining irrespective of whether they joined in 1974 or 1975. Confusing ?
